

Sample student behavior report

On Friday, April 9, 2010, at 9:45 a.m., student Frank [Atty/Clie] threw a lunch tray at another student.

The other student was hit in the face. [Atty/Clie] said he didn't care. A teacher attempted to step in between the two students. The teacher was then hit in the face with another lunch try coming from the west side of the cafeteria.

Students began throwing food all around the cafeteria despite lunch monitors blowing emergency whistles. Students were jumping on cafeteria tables, throwing food, yelling at each other, and running around the cafeteria.

The following students were injured in the cafeteria:

- Bob Samson, Student ID# [Privacy Info]
- Lisa Frank, Student ID # [Privacy Info]
- Michael Scott, Student ID # [Privacy Info]

Injuries included head contusions, broken legs, and dislocated shoulders.

[Atty/Clie] told administrative staff he didn't want to be at school anymore and did not care that he was going to get in trouble and was facing expulsion. I questioned the students around [Atty/Clie] (Anna Morgan, Student ID # [Privacy Info]). She told me:

- [Atty/Clie] threw the tray because the other student was making fun of him.
- The other student stated [Atty/Clie] started the fight and he was just responding.

[Atty/Clie] was removed from the cafeteria by the resource officer and taken to the administrative offices.

This happened at 10:35 a.m. on April 9.
